



**RELEASE OF LIABILITY, ASSUMPTION OF RISK, HOLD HARMLESS,  
AGREEMENT TO INDEMNIFY AND NOT TO SUE FOR  
PARTICIPATING IN BOCCE LEAGUE OF ROCHESTER, LLC.**

In consideration of being allowed to participate in any way in Bocce League of Rochester, LLC including related events and activities (collectively “the Program”), I the undersigned and above-named, acknowledge, appreciate, and agree that:

1. Participation in the Program involves personal and property risks. Property risks include, but are not limited to: torn clothes, scuffed sneakers, and broken glasses. Physical injuries may be serious or minor, including but not limited to: head or neck injuries, loss of sight, broken bones, brain damage, paralysis, and death.
2. I hereby certify that I am physically fit to participate in the Program.
3. I expressly understand and agree that to abide by all policies, rules, and regulations of the Program.
4. **I expressly, knowingly, and freely assume any and all risks of damage to or loss of property; personal injury; and/or death associated with, arising out of or related to my participation in the Program.** I expressly understand that the Program, its founders and/or agents assume no responsibility for my loss of property; personal injury, and/or death, be they caused by act of god, accident, negligence or willful misconduct.
5. Recognizing and understanding the potential risks of injury, I agree not to sue and defend, indemnify and hold harmless the Program, its founders, its agents, representatives, and employees (collectively “the Program and its Agents”) for any loss, damage, or injury associated with, arising out of or related to my participation in the Program regardless of cause.
6. I hereby release and discharge the Program and its Agents, who through negligence, carelessness, or willful misconduct, might otherwise be liable to me, my heirs, personal representatives, relatives or assigns from all liability associated with, arising out of, or related to my participation in the Program.
7. I agree that this release of liability, assumption of risk, hold harmless, agreement to indemnify and not to sue is to be as broad and inclusive as is permitted by the

laws of the State of New York and that if any portion of it is held invalid it is agreed that the balance shall continue in full force and effect.

8. I understand that by signing this release of liability, assumption of risk, hold harmless, agreement to indemnify and not to sue, is legally binding on me, my heirs, personal representatives, relatives and assigns and that I am giving up my legal rights and remedies which otherwise would be available to me my heirs, personal representatives, relatives or assigns against the Program and its Agents.
9. **I have carefully read this release of liability, assumption of risk, hold harmless, agreement to indemnify and not to sue and fully understand it.**
10. I am of legal age and voluntarily sign this release of liability, assumption of risk, hold harmless, agreement to indemnify and not to sue.
11. I hold myself responsible and assume all risk associated with the consumption of alcohol. I understand that the Bocce League of Rochester, LLC is not liable for my actions associated with this.
